## Draw Hunting Summary For the TMA and Delta Controlled Use Area:

Drawing hunts require an application fee and are awarded by lottery. Each year, the Alaska Department of Fish and Game (ADF&G) publishes a Draw Hunt Supplement with specific information containing the drawing hunt opportunities and area boundaries. To see a map of the TMA (ds102 and ds103) and adjacent Delta (ds203 and ds204) Go to: <http://www.adfg.alaska.gov/static/hunting/maps/huntmaps/575/ds102.gif>

### When to Apply:

The next application period for Draw hunts will be November 1 – December 31, 2011. Paper applications will be accepted during the month of November, while internet applications will be accepted during November and December.

### How to Apply for Draw Hunts:

Hunt numbers for the TMA are DS102(Aug.10th - Aug.25th) and DS103(Aug.26th - Sep.20th) Hunt numbers for Delta are DS203(Aug.10th - Aug.25th) and DS204(Aug.26th - Sep.20th)

- You will need to purchase a valid hunting license if you do not already have one.
- **Purchase your hunting license and drawing permits online at:**

- **(Be sure to write Matthew Snyder in as your registered guide and include up to three hunt numbers for your choices.)**
- Non-resident hunters are also required to have a signed Guide-Client Agreement prior to applying for certain hunts. Go to:
